Some MARCH Reminders...

Confirmation of Eligibility

Eligibility confirmation is Task 4 on the delegation log — this can only be completed by a **physician** who is listed on the delegation log.

Telephone Consent

Must be witnessed by a second member of staff and the telephone agreement form countersigned. This witness does not have to be on the delegation log.

Pregnancy Exclusion Criterion

All women of childbearing age (15-55) must have a pregnancy test performed, (serum or urine) before recruitment, and pregnant patients excluded. It is a protocol deviation if a test is not completed and documented.

IMP Continuation

If the treating clinician decides to continue the IMP(s) post-primary outcome, it must be documented in the medical notes. If continued in error, or not documented, this is a protocol deviation.

Spotlight on Royal Stoke

This month, we caught up with Michelle Davies at our top recruiting site, Royal Stoke University Hospital, to learn more about their secrets to success on the MARCH trial.

Involve the physio team in screening e.g. handover sheet with eligibility criteria listed • Encourage participation in API Scheme • Difficult to clear secretions identified via key terms on physio notes • Patients prescribed normal saline flagged for screening.

Communication is key • Highlight eligibility criteria at research meetings • Involve those who usually prescribe mucoactives e.g. ACCPs • Link with bedside nurses.

Reassure relatives • The study uses drugs that are routinely prescribed locally already • Present study as a 'gathering of information'.

Share the love. Nominate local research stars. • Distribute treats amongst all teams involved, including non-research staff.
